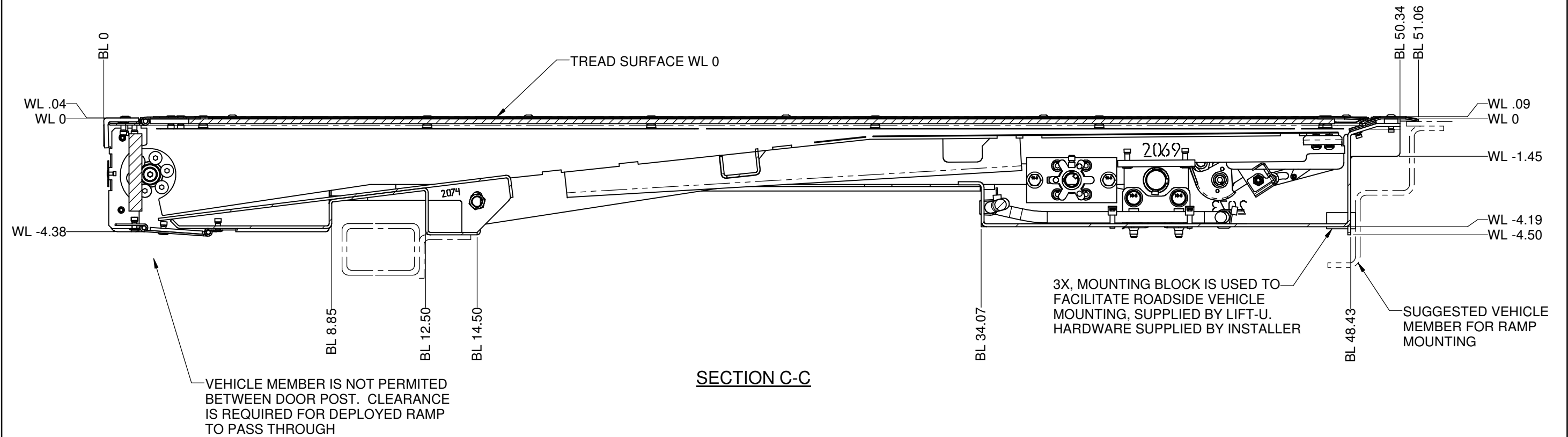


ELEVATION VIEW RAMP STOWED

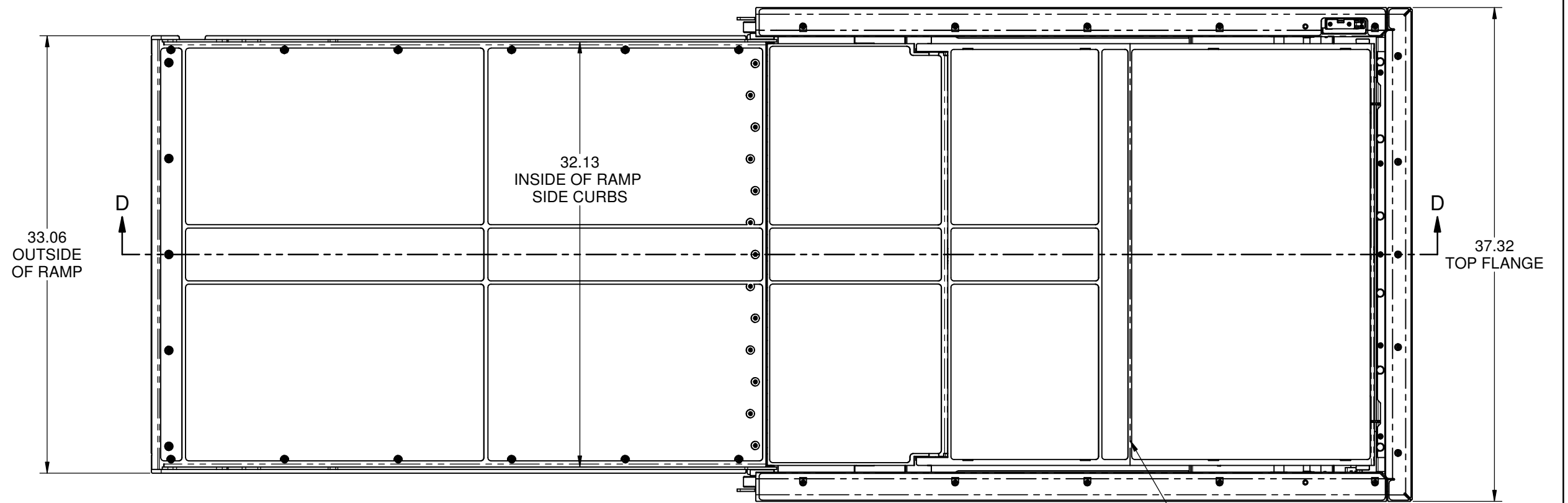

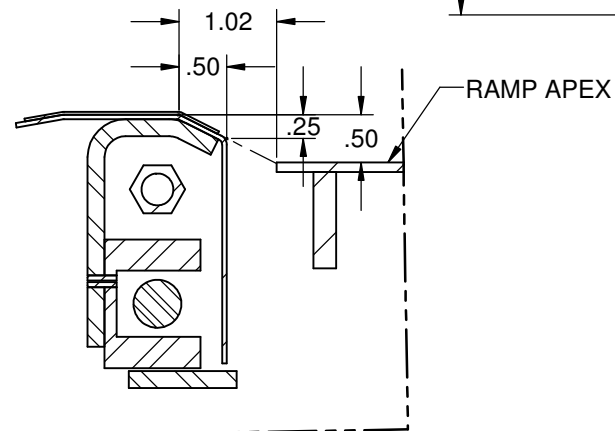

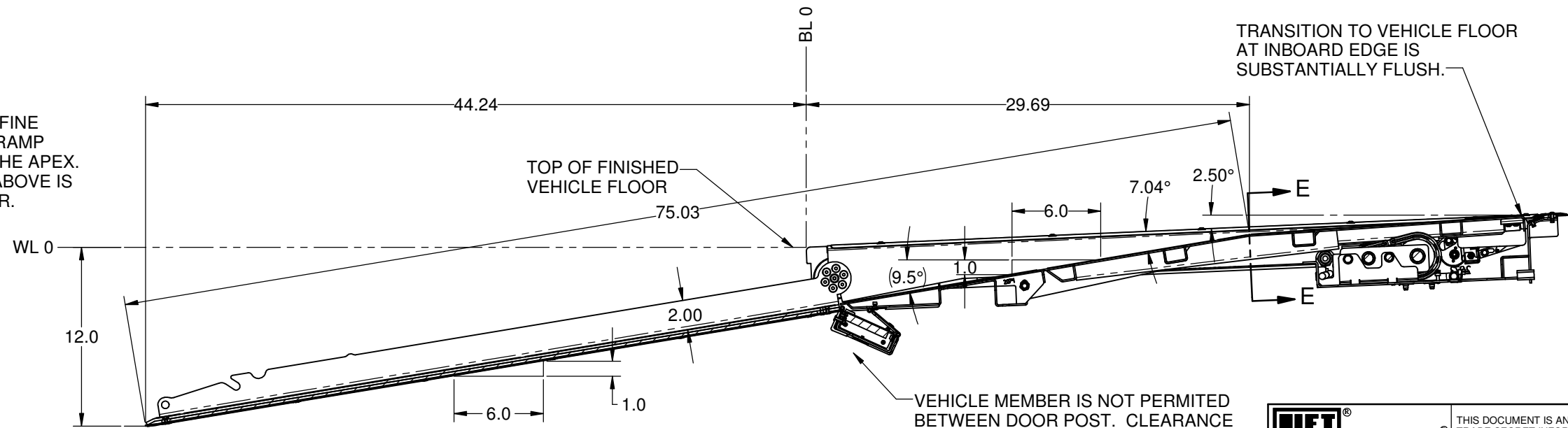


PLAN VIEW

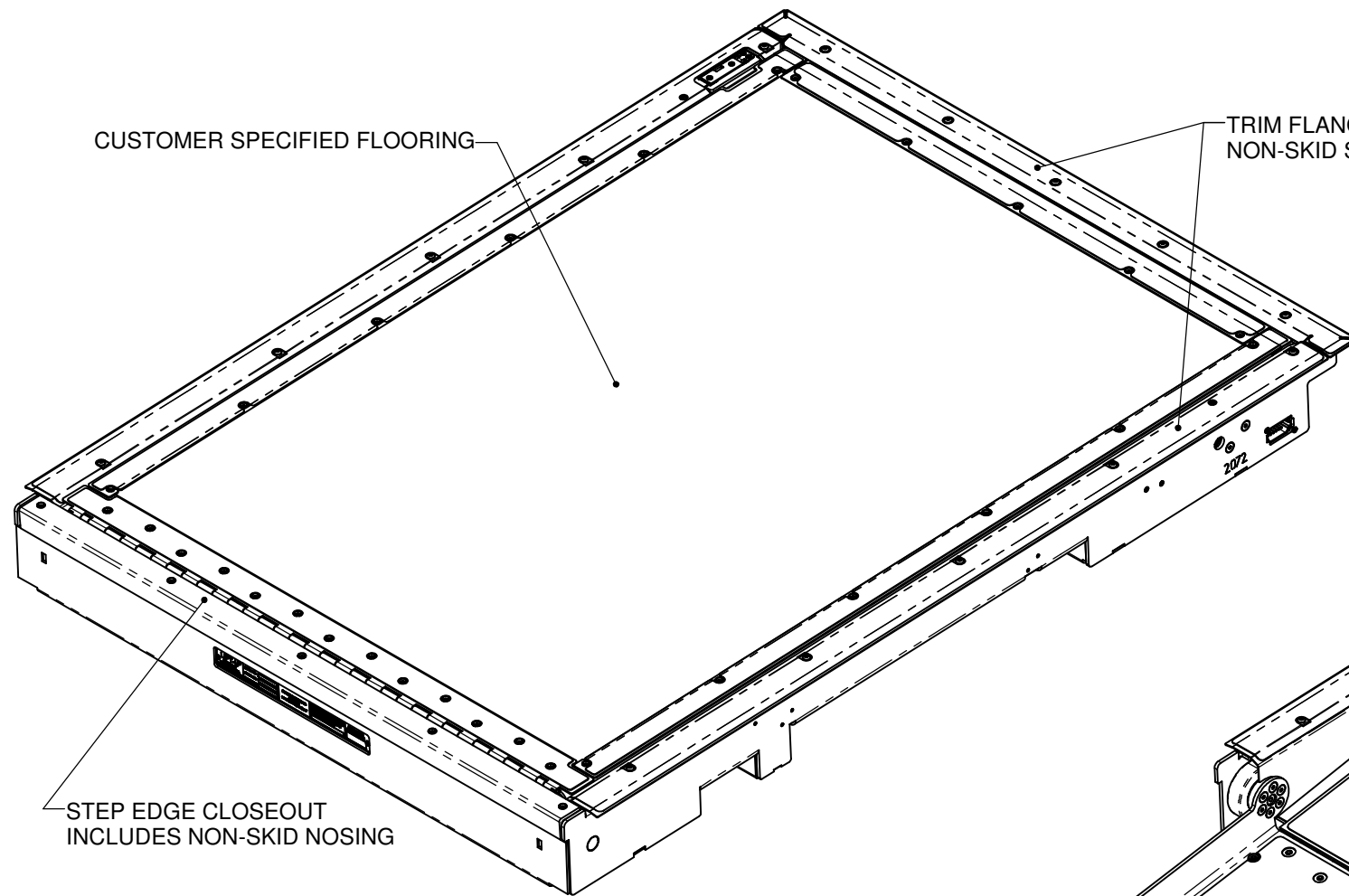

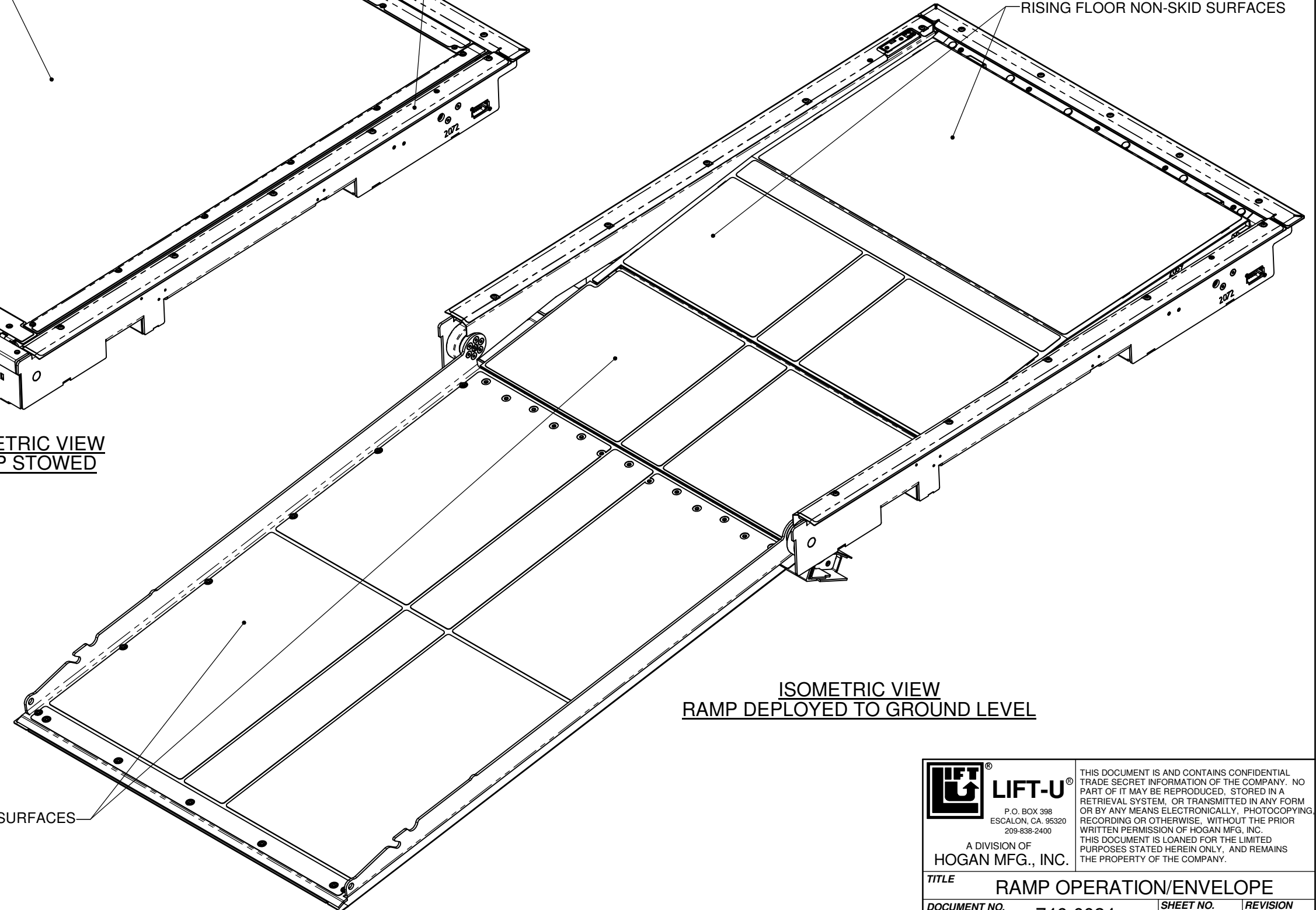

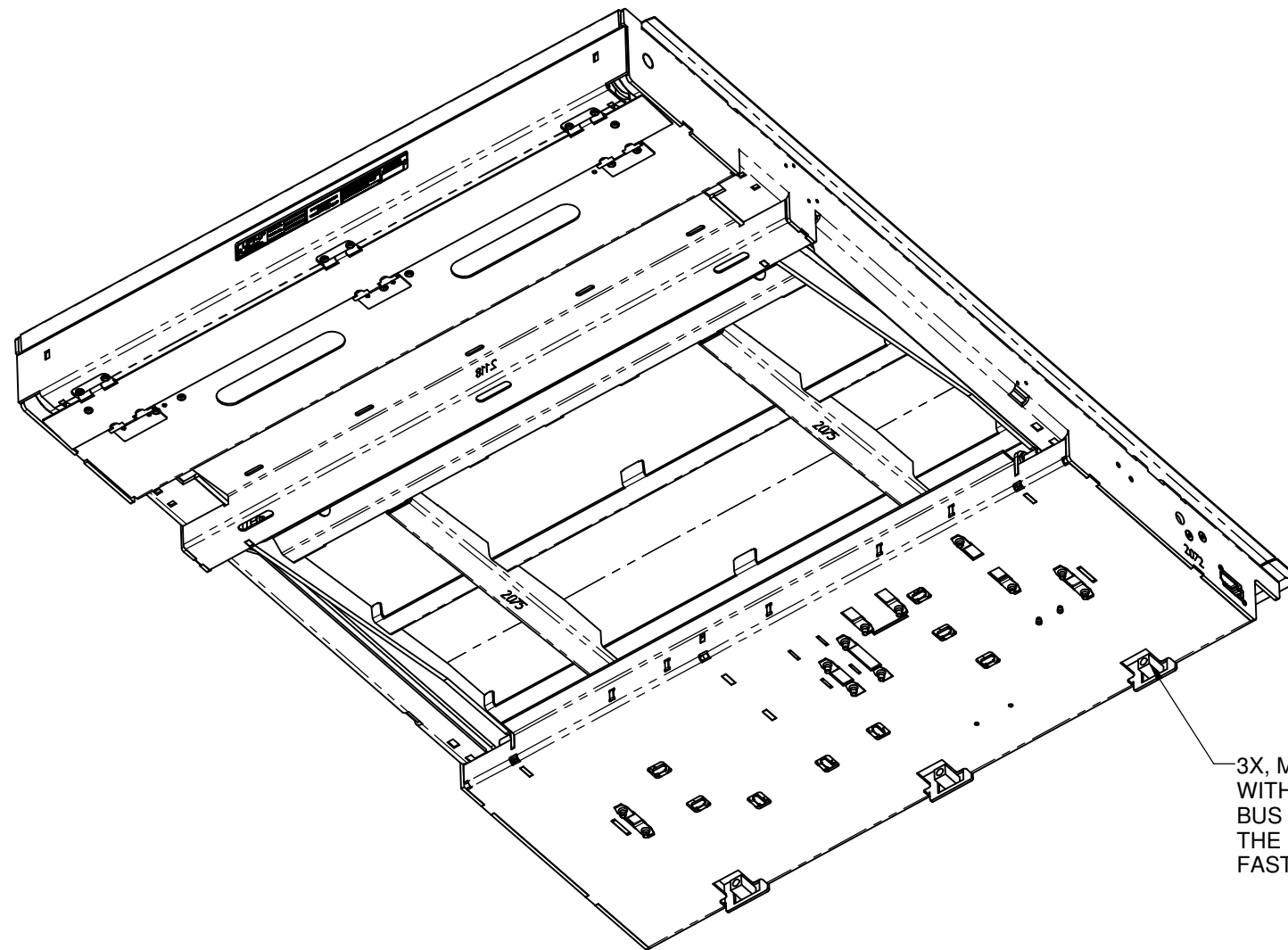
